

Dear Limo Customer,

We would like to inform you that from 21 June 2024, we are amending the General Terms and Conditions of MOL Limitless Mobility Ltd. and its Annexes, in particular the Privacy Notice. Here are the main changes:

- renewal of the Limo Zone
- changes to the Airport Holiday Parking zone fee
- changes to the use of credits
- a new penalty for reporting damage will be introduced
- changes to our Privacy Notice

### Limo-zone renewal

The Limo-zone is being continuously improved based on customer feedback to ensure the best possible coverage and high availability for our customers.

The Limo-zone will be expanded in the following areas:

### Airport Holiday Parking zone fees are changing

For rentals starting from 21 June 2024, a zone fee of HUF 2990 is payable at the end of the rental period in the Airport Holiday Parking and HUF 1490 at the start of the rental period.

### Changes to the use of credits

Limo credits cannot be used to pay zone fees.

### A new damage report penalty has been introduced

In order to maintain and improve the condition of our fleet, we have introduced a new penalty item: failure to report damage prior to the start of the rental period will result in a penalty of HUF 30 000.

If the User finds new damage to the car, in addition to the damage already reported in the app, he/she is obliged to upload a photo of the damage to the app.

## Amendments to the Privacy Policy

The most important change is that general and personalised marketing messages, as well as marketing messages concerning third parties as contracted partners, may be sent to the User, provided that the User has given his/her specific consent. Consent may be withdrawn or modified.

Should You further use the Service after GTC was changed, this will be considered as Your acceptance of the GTC with the amended rules. In case You do not want to further use the Service, You are entitled to request the deletion of Your User Account and thus terminate without the need for justification the Framework Agreement concluded for the usage of the Service. The Framework Agreement shall terminate with the deletion of Your User Account.
